CONTEST CATEGORIES: Popcorn, Video Games, Plants, & Goggles

RULES & REGULATIONS: All entrants must be enrolled as 4-H members 30 days prior to contest/show date. Counties may enter junior, intermediate and senior teams. A team consists of at least (3) three and no more than (4) four individuals. Individuals can also participate. Mixed county teams will also be accepted.

The "Exhibitor Release and Indemnification" form must be completed, notarized and submitted with the fair show registration form.

AGE GROUPS - as of September 1, 2010:

- * Juniors are 8-10 years
- * Intermediates are 11-13 years
- * Seniors are 14-18 years

Cloverbuds may participate on a non-competitive basis and will receive a green participation ribbon.

AWARDS: Teams (Junior, Intermediate and Senior)

First place team in each age division will earn a team trophy, a \$12 premium, and a rosette for each team member. Second place team will earn an \$8 premium and each contestant will receive a rosette. Third place team will earn a \$4 premium and each participant will receive a rosette.

AWARDS: Individuals (Junior, Intermediate and Senior)

First place individual in each age division will earn a trophy and a \$4 premium. Second place individual will receive a rosette and \$3 premium. Third place individual will earn a rosette and \$2 premium. Cloverbuds and all other participants that do not place will earn a ribbon of participation.
