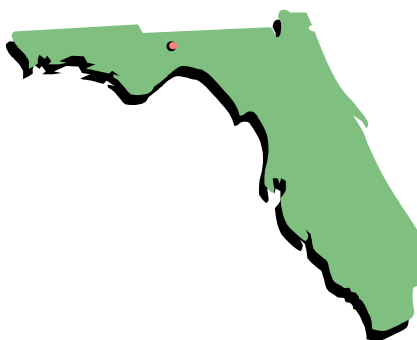

Rules

- Approved headgear, boots and proper attire are mandatory. **The Exhibitor Release and Indemnification form must be completed, notarized and submitted with the fair show registration form**
- **Any questions arising that are not covered in the rules will be decided by the judges and/or the show committee.**
- Only (1) Rider is permitted per horse/pony per class.
- No Stallions shown or on grounds
- No alcoholic beverages, smoking, or illegal drugs are allowed on show grounds
- Horse must be healthy and not show evidence of any contagious or infectious disease; animals that fit this description are to be removed from the grounds immediately.
- All trailers will be directed to designated livestock parking area, horses may not be tied to arena or any fencing.
- No mopeds, 3 or 4 wheeled ATV vehicles except for official use.
- No unleashed dogs
- No smoking in buildings. Includes bleachers under pavilion
- **Any act of discourtesy to judge or show officials by an exhibitor or any other attendant will be grounds for disqualification and forfeiture of fees.**

Tack and Attire:

- SEI approved safety helmets (w/ safety harness securely fastened), boots with heel, and exhibitor number worn at all times in the middle of the riders back on the grounds.
- Please dress appropriately, no revealing clothing.
- Horse/pony may not be exhibited in a halter
- Chaps, bats, crops and strapped spurs are optional. Clip on or slip on spurs are not allowed, protective gear is strongly recommended (i.e. shin guards)
- No over-under whips are allowed
- You are representing St. Johns County Fair. Cleanliness and proper grooming of yourself and your mount is expected.

Gymkhana Rules:

- SAFETY IS OF THE UTMOST IMPORTANCE!
- All classes will be run with a closed gate.
- Horses MAY NOT run outside of designated show or practice areas otherwise resulting in disqualification and dismissed from the grounds.
- Over use of whips, bats, ropes, reins, etc., will result in disqualification.
- In the event of a tie, a run off will be held.
- Any rider with equipment the show committee or judge considers to be unduly severe or unsafe, or using equipment in a severe or unsafe manner may be disqualified
- Each contestant will be called 3 times by name/number (in hole, on deck, up). The contestant will have 30 seconds to enter the arena after the last call. Contestants much start their run within 30 seconds after entering the arena.
- No handlers, to help contestant are permitted in arena unless an emergency.

Patterns will be posted at gates

Timing

- These are timed events and the goal is to compete the course in the fastest time.
- The gymkhana classes, the class starts when the horse/pony crosses the timer line, and stops when the horse/pony crosses the timer line on their return.
- An electric timer will be used and is official, unless the timer defects.
- A rerun will be given in gymkhana classes for timer failure providing a qualified pattern is run. Only one rerun is given (unless timer fails). The reruns will take place at the end of the class. If the contestant disqualifies during the rerun, no additional runs are given.
- If timer breaks, 3 stop watches will be used for time. Official time will be the middle of the 3 times.
- Start/Finish line will be marked, no less than 30' from gate/entrance

Exhibitor hereby agrees to defend, indemnify and hold the Fair harmless from and against any claim, demand suit, loss, causes of action, damages, liabilities, obligations, costs (including attorneys' fees and costs), expenses, and judgments (including without limitation, personal injury or death, and damages to property) resulting from or arising out of Exhibitor's acts or omissions regardless if such injury, death or loss of property is caused in whole or in part by the negligence, conduct and/or omissions of the Fair or not.
